## Middletown Arts Center (MAC) TOMORROW'S ARTIST TODAY

### ELIGIBILITY REQUIREMENTS:

Any artist between 13 and 18 years of age, and must be in Jr/Sr. high school, is eligible to submit artwork.

### CATEGORIES:

- 1) PAINTING (oils, acrylics, watercolor, gouache, tempera)
- 2) DRAWING (pastels, pencils, charcoal, inks)
- 3) PHOTOGRAPHY, PRINTMAKING, & DIGITAL ART (2D works only)
- 4) 3D WORKS (ceramics, sculpture, jewelry, metals, leather, glass, fiber)
- 5) MIXED MEDIA (a work showcasing more than one of the above mediums)

\*\*\*Medias must be written on submission form

- More than one category may be entered.
- All works must be original and never exhibited previously in a juried exhibit at the Middletown Arts Center.

### RECEIVING AND CONDITIONS OF ENTRY:

All entries must be delivered to the MAC, 130 N. Verity Pkwy, Middletown, OH during the dates/times per exhibit calendar on back, no exceptions.

2D artwork should be matted and/or framed, or canvas. If framed or canvas works, they **must** have wire for hanging (no tape or saw tooth hangers allowed). If canvas boards only, an adhesive picture hook will be applied to the back for hanging. If matted only, works **must** be permanently adhered to the mat (clips will be used for hanging from the top edge of the mat).

- 2D WORKS: The total size (frame included) cannot exceed **36 x 36 inches**, weight cannot exceed **40 lbs.**
- 3D WORKS: works cannot exceed **15"** in length or width, weight cannot exceed **40 lbs.**
- NO TAPE OF ANY KIND IS TO BE USED:  
Unsuitable presentation will be grounds for decline.

**ENTRY FEE:** There will be a **\$5 non-refundable fee per entry. Cash or Check only** - checks payable to Middletown Arts Center.

There is no limit to the number of entries submitted; however, a maximum of 3 pieces per category will be accepted for each artist.

*Submission Forms must be filled out completely and correctly at time of entry. Early submission forms for schools available upon request by teachers.* One form per entry is required.

Include: teacher's name, school, school address and number of forms needed.

**SALES:** The sale of art work is encouraged. The MAC forgoes retaining our standard 30% commission for teen artwork sold in Tomorrow's Artist Today, **artists receive full sales compensation.** If for sale, forms must be filled out with Artist home address, not school address, for mailing compensation. If the work is not for sale, please indicate by marking "NFS."

### EXHIBIT NOTIFICATION AND RETURN OF WORK:

Notification of **ACCEPTANCE** into the show will be posted on [www.middletownartscenter.com](http://www.middletownartscenter.com) by **January 17, 2023.** Declined work may be picked up after January 23. **February 16, 2023.** All work not claimed 60 days from close of exhibit becomes the property of the MAC.

**LIABILITY/AGREEMENT:** All reasonable care will be taken in handling work submitted; however, neither the Middletown Arts Center, the judge, nor the committee will be held responsible for loss or damage to works of art. All works are entered at the artist's risk, and the artist must provide his/her own insurance. Submission of work to this exhibition shall be understood to indicate an agreement on the part of the artist with conditions set forth. This includes the artist's permission to have photographs of their work used for publicity and for promotion without compensation.

### EXHIBITION AND PREVIEW EVENT:

Tomorrow's Artist Today will be open to the public during business hours January 21 through February 16. The opening PREVIEW EVENT will be Saturday, January 21, 10 am—noon.

Awards will be placed next to winning pieces at the PREVIEW EVENT and announced by January 23 via our social media platforms and [www.middletownartscenter.com](http://www.middletownartscenter.com).

We do encourage all students, families, teachers and public to visit the exhibition and celebrate the wonderful work the students have accomplished!

### AWARDS:

<b>Best of Show</b>	<b>\$200</b>
<b>First Place</b>	<b>\$100</b>
<b>Second Place</b>	<b>\$50</b>
<b>Third Place</b>	<b>\$20</b>
<b>Honorable Mention</b>	<b>Ribbon</b>

There must be 8 accepted pieces in a category to be judged for 1st, 2nd, & 3rd. For categories not meeting 8 piece minimum, judge(s) **may** elect to award Honorable Mention. Best of Show will be chosen from **all** accepted exhibition entries and categories. The final decision, in all cases, rests with the judge(s).

### JUDGE:

Judging for exhibition will be done by judge(s) chosen by the Exhibit Committee. Decisions of the judge(s) are final and binding.

MAC reserves the exclusive right, and sole discretion, to reject work that does not meet our criteria.
